NOTE ITEMS:

- All students will apply to the Aeronautics-Pilot Training associate degree or Aeronautics-Professional Pilot technical diploma program. Students who decide to start with the Aeronautics-Professional Pilot program will have the option to apply and continue with the Aeronautics-Pilot Training program at any time. * Veterans utilizing any federal benefits should apply directly to the Aeronautics-Pilot Training program.

The Aeronautics Programs at Fox Valley Technical College operate based on a first-come, first served policy per the Wisconsin Technical College System.

- The Aeronautics programs are in high-demand and we see a high volume of interest; please plan accordingly.
- To most efficiently serve the students in this high demand area, the programs operate on a constant out/constant in model.
 - If your position is such that you are eligible to enroll in core courses for the next available start, but do not, you may bypass up to a maximum of three times, at which time you would be moved to the bottom of the flight ready list to most fairly accommodate others waiting for the opportunity to begin training.
- After successful completion of Phase I, students will be officially admitted to the college.
 - Attendance to a New Student Orientation session is mandatory. These are typically offered on a monthly basis; please plan accordingly.
- Once students are admitted to the college, successful completion of the tasks outlined within Phase II of this guide will be mandatory for the Aeronautics program and official FAA Part-141 enrollment. Failure to complete any of the necessary steps will result in delayed start or program withdrawal.
 - This includes the FAA 1st or 2nd Class Medical Certificate & FAA Equipment Verification
- Official progress tracking and completion of the items contained in this guide can be viewed through your MyFVTC account at <http://www.fvtc.edu/MyFVTC>. (To-do list on far-right side of login page) Clicking [To-Do List Details](#) provides additional detail on each task. *NOTE – Items in your To-Do list labeled as “Initiated” are items you must complete or require your attention.
- Students are required to assess their finances and make arrangements to have payment available prior to the first day of flight courses. We encourage students to apply for Financial Aid (if necessary) and to review the previous year’s academic planner for estimate course costs (*course fees are subject to change). Documentation Guidelines & Compliance:

The Aeronautics Programs require students to submit many documents that are required for Fox Valley Technical College, the Federal Aviation Administration and Transportation Security Administration. When presenting any documentation, students are required to submit all items to an FVTC Representative at the S.J. Spanbauer Aviation & Industrial Center **ONLY**. Documents/scans taken from any other campus location will not be accepted. Please ensure all of your documentation meets compliance standards. If documentation does not meet the following criteria, students will be asked to resubmit their items:

- Full-color
- No corners or wording have been cut off
- All information is current legible

- Fill out form (page 9) and submit as stated on page 6

Verification of Citizenship

- **Current U.S. Passport:** scan image of current, signed and open passport
- **Official Birth Certificate & Driver's License:**
 - i. Birth Certificate: scan image of full birth certificate (front only)
 - ii. Driver's License: scan image of front & back of license; ensure all images are clear.
- **Certificate of Naturalization & Driver's License:**
 - i. Certificate of Naturalization: scan image of full certificate of naturalization
 - ii. Driver's License: scan image of front & back of license; ensure all images are clear.

1st or 2nd Class FAA Medical Certificate:

- Confirm FAA Medical Certificate is signed & has been issued within the last 12 calendar months.
- Scan copy of original medical and submit as stated on page 8
 - Please remember FAA prohibits tampering with document; lamination, removing conditions of issue, etc.

Student Pilot or Current Pilot Certificate:

- Confirm certificate is signed
- Scan images of front & back of pilot certificate as outlined on page 7

(b) be at least 14 years of age for the operation of a glider or balloon (c) be able to read, speak, write and understand the English language. If the applicant is unable to meet one of these requirements due to medical reasons, the administrator may place such operating limitations on that applicant’s pilot certificate as are necessary for the safe operation of the aircraft. <p>ii. This process will take a minimum of four weeks for the TSA to complete required background checks and may take longer to receive your FAA issued certificate. Be sure to plan ahead and start this step early. I understand that it is my responsibility to keep this guide up-to-date by complying with the required admissions steps, making certain that I understand them. I accept that non-compliance of these steps may result in my ineligibility for program admission for the intended term of enrollment. I further understand that this declaration is similar to a contract and that it is my responsibility when signing such a declaration to understand its content, implications and intent.

I understand that the Aeronautics Programs serve students based on a first-come, first-served policy per the Wisconsin Technical College System. As the Aeronautics Programs operate on a constant out/constant in format, I understand that I be notified when I am within the top 10, top 5 and have officially been invited in for a flight seat. Should I not be able to have a final decision within (5) business-days of notification, I will have to wait until the next flight seat becomes available, unless I have an extenuating circumstance. If I pass my seat three times, I will be moved to the bottom of the flight ready list.
