

**NOTICE OF INTENT TO APPOINT
FOX VALLEY TECHNICAL COLLEGE DISTRICT BOARD MEMBERS**

Notice is hereby given that the Board Appointment Committee of the Fox Valley Technical College District Board will accept applications for the appointments of three persons to the Fox Valley Technical College District Board, in accordance with the Appointment Committee's Plan of Representation, which specifies categories of membership as well as geographic areas of representation within the District. One position of additional member will fulfill a term from March 2025 through June 30, 2025. The other positions (employer, employee, and additional member) will commence on July 1, 2025, and upon certification of the Wisconsin Technical College System Board. All positions carry three-year terms expiring June 30, 2028. Following is a list of openings:

EMPLOYER MEMBER: To qualify as an employer, you must receive earnings as payment for your service and possess the power to hire, transfer, suspend, layoff, recall, promote, discharge, assign, reward, or discipline other employees or adjust employee grievances or effectively recommend such action if in connection with the exercise of such power the person exercises independent judgment in relation to the power. Employer does not include a person acting in the capacity of officer or agent of a labor organization. At the time of their appointment, employers also must be actively engaged in business and employ others.

EMPLOYEE MEMBER: You receive payment for work performed but do not qualify as an employer using the definition described above. An officer or agent of a labor organization automatically qualifies as an employee.

ADDITIONAL MEMBER: All residents of a technical college district are eligible to serve as an additional member for that college.

The **Plan of Representation** states that equal consideration is given to the general population distribution within the FVTC District as well as to the distribution of women and minorities. Consideration is also given to representatives of business and industry as required for employee and employer representatives. Board members receive no compensation, except for expenses incurred in the performance of their duties.

Applications must include one page single-spaced statement describing your reasons for seeking an appointment to the board, and at least two letters of recommendation. **Applications will be accepted no later than 4:00 p.m. on January 14, 2025.**

The **Public Hearing** date has been established for **Monday, February 3, 2025, 6:00 p.m.** Candidates for Board consideration must attend to be interviewed by the committee, and give an oral presentation no longer than five minutes in length. No additional names will be accepted from the floor at the time of this meeting.
